Thursday, June 16, 6:30pm House of Prayer

Following instruction, members will spend approximately one hour prepping provided fabric for dying. The second half of our evening will be spent outdoors where indigo vats will be set up for fabric dying. *Plan to wear old clothes and shoes or bring an apron*. Please bring the following items; all other supplies will be provided:

- 1. Small sharp scissors and/or seam ripper
- 2. Sharp Needle
- 3. Rubber gloves (like Playtex)
- 4. Disappearing fabric marker

To make the most of our evening, there will be **no show** and tell. If the weather does not allow the outdoor activity, we will prep our fabric and dye at another time.

What is Shibori?

Shibori is the Japanese word that means "to wring, squeeze, press." Simply, cloth is given a three dimensional form by

crumpling, stitching or twisting, through binding and knotting, to create resist *prior to dying*.

Missouri Valley Quilt Guild Board Meeting Minutes June 7, 2022 via TEAMS

Members present: Laurie Sheldon, Maxine Bondeson, Sandi Washek, Teresa Chase, and Michele Ripplinger.

Michele reported that the bank balance has not changed.

Janice Hokenstad has volunteered to again chair the National Teacher Committee. Sandi has provided her the list of suggested teacher possibilities. Jan will need committee members.

Sandi will bring State Fair registrations to the June meeting. Registrations may be done by mail or online. State Fair entry registration deadline is July 6th. Michele plans to drive entries to Minot on July 18th and pick entries up on July 31st. Michele and Sandi stated they or agreeable to putting their phone numbers in the newsletter for the purpose of coordinating transport of the entries.

A Christmas party committee is needed.

After discussion it was decided that the August picnic will be held at the church, rather than Sertoma Park. Show and Tell will resume at the August meeting.

Laurie reported on the Shibori/Indigo class preparation she has done and outlined how the program will run. Sandi has taken handouts to Flash Printing. Laurie reported that indigo dye will cost approximately \$30, 10 yards of PFD cotton fabric will cost \$86.57, and incidentals will cost approximately \$20. Board members decided to pay Laurie \$50 to help defray the cost of supplies she has purchased and will retain. The entire cost of the program will not exceed \$200.

The summer challenge was discussed. Participants are asked to use their indigo fabrics in a sewing project of their choosing. Members unable to attend the June program but wishing to participate should contact Laurie and she will mail dyed fabric to them. Projects will be due at the September meeting.

In order to maximize activitiv time, the June business meeting will be brief and there will be no show and tell.

There will be no meeting or newsletter during the month of July.
