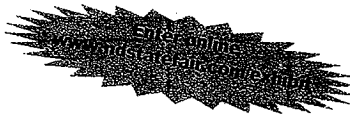

- **DEADLINE FOR ENTRY FORM: JULY 5, 2018.** Exhibits cannot be accepted unless an entry blank is properly filled out and on file with the Fair office prior to the closing date for entries. **DUE TO THE COMPUTER ENTRY PROGRAM, YOU ARE ENCOURAGED TO MAIL YOUR ENTRY BLANK IN AHEAD OF ENTRY DAY.** The Fair management is not bound to accept entries made after the deadline. Use separate entry blanks for each department (i.e. flowers, needlework, etc.).
- Competition is open to North Dakota residents only.
- Any article, having been properly entered, can be forwarded by mail or prepaid express to Dept. 113, ND State Fair, PO Box 1796, Minot, ND 58702, who will then place the goods on exhibition. The management however, will not be responsible for any breakage of glass or loss of any article. Send complete list of articles contained in the package. Mailed exhibits must reach the Fair office no later than 5pm Friday, July 13.
- Exhibitors in this division may bring their exhibits to the 4-H Hall in the ND State Fair Center on Friday, July 13 from 10am to 5pm and on Monday, July 16 from 10am to 5pm. No entries will be accepted after the deadline. Judging will begin Tuesday, July 17 at 8:30am.
- **EXHIBITS WILL NOT BE RELEASED BEFORE 6 PM ON THE LAST DAY.** Exhibits may be picked up on Saturday, July 28 between the hours of 6pm and 8pm or on Sunday, July 29 between 10am and 2pm. A claim check must be shown before release. The building will close at 8pm Saturday, July 28. Those picking up exhibits on Saturday, July 28 must pay gate admission.
- No person can enter more than one item under the same class number in any division. The "any other" class is for items not listed.
- The judges are instructed not to award prizes unless the articles are deemed of real merit, even though they may be the only entry in the class.
- Best of Show ribbons will be awarded in each department at the discretion of the judge.
- **Any article exhibited in prior years at the North Dakota State Fair is ineligible to show.**
- Please enter exhibit under person's name who made it.
- Unless exhibits comply with these rules, they will not be accepted.

The prize money appropriated by the state budget process has been reduced by state government for our 2018 Fair. State Fair shall be required to reduce cash prizes accordingly. The State of North Dakota provides only the prizes at State Fair, all other operational funds are derived from the Fair's income. Cash awards will be mailed September 2018.

Division J - Quilting

Sponsored by the Minot Prairie Quilter Guild and the
North Dakota State Fair

Premiums: \$6.00 • \$5.00 • \$4.50

100% of monies sponsored by North Dakota quilt guilds and quilt shops will be added to premiums in this division. Quilts including more than one technique should be entered in the category of the predominant technique. All quilts must be constructed and quilted by the person entering them, except for the "commercially quilted" and "group categories." The term "Machine Quilted" indicates that the person entering the quilt did the quilting on a home sewing machine or on their own longarm machine. A quilt is a fabric sandwich (three layers) held together with hand or machine quilting stitches. Mixed techniques must have at least 2 techniques, i.e., piecing, applique, embroidery, trapunto, folding, etc. No hanging rods please. The State Fair reserves the right to move an entry to another class or combine with another class as needed. **All quilts that fall in the "Commercially Quilted" category need to list the name of the Quilter.**

Small Wall Hanging - intended for use on a wall, must have sleeve (less than 120" perimeter)

29. Hand Quilted - any technique
30. Pieced - Machine Quilted
31. Appliqué - Machine Quilted
32. Any **Miniature** (less than 96" - maximum 24" per side) blocks must be 4" or less and a replica of a large pattern)
33. **Garment or Accessory** - any technique, must include quilting
34. **Household Items** - any technique, must include quilting (any table topper, placemats, pillows, or kitchen accessory)
35. **Holiday Theme** - any technique, must include quilting
36. **Beginning Quilter** - any size (having quilted for one year or less) Special Ribbon
37. Local Guild 2018 "**Challenge Quilt**"
(include name of guild and challenge rules).
38. "**Group Quilt**" - Bed Quilt (include names of quilters group)
39. Quilt Top Made with "**Recycled Fabrics**"
40. "**Memory/Album Quilt**"
41. Other **Special Techniques**, including cross-stitching, yo-yos, felt, hand tied, embroidered, whole cloth, etc.
42. "**Found and Finished**" - include sample of the quilt or materials
43. "**Modern**" - A quilt using a new design or reinterpreted traditional design, including improvisational piecing, alternative block structures, or emphasis of negative space and asymmetry
44. **Display Only** - any size, any quilting method
45. **Youth - Ages 10 and under and 11-17** (state youths age) Any size, any quilting method
